



# THE MAIN OBJECT TO BE PURSUDE BY THE COMPANY ON ITS INCORPORATION:-

- The Board of Directors may raise or secure the payment or repayment of such manner and conditions in all respects they think fit, and in particular by the issue of debenture stock of the company, charged upon all or part of the property of the company (both present and future) including its uncalled capital for the time being.
- Debentures, Debenture stock and other securities May be made assignable from any equities between the company and the person to whom the same may be issued.
- Any debentures, debenture stock bonds or other securities may be issued at a discount, premium or otherwise and with any special privileges as to redemption, surrender, drawings allotment of shares, attending and voting at General Meeting of the Company, appointment of Director and otherwise.
- If any uncalled capital of the company is including in or charged by any mortgage or other security, the Directors may by an instrument under the company's seal authorize the person in whose favor such mortgage or security is executed or any person in trust for him to make calls on the members in respect of such uncalled capital and the provisions herein contained in regard to call shall mutatis mutandis apply to the call made under such authority and may be made exercisable, either conditionally either presently or continentally and to the exclusion of the Directors powers or otherwise and assignable if expressed so to be.



## **Proceeding of Directors:**

- Subject to the Provisions of section 289 of the companies Act, 1956 a resolution of the Board duly passed at a meeting.


